- 02. Bidding will be conducted through National Competitive Bidding (NCB) Procedure.
- 03. To be eligible for contract award, the successful bidder
  - Shall not have been blacklisted.
  - Shall meet a valid CIDA grade as indicated in the above table **or** shall have a valid business registration in Sri Lanka for last five years and shall be accredited and registered under ISO 9001/ ISO 14001. Documentary evidence to support bidder's experience and track record shall be provided with the Bid.
- 04. Qualification requirements to qualify for contract award include:
  - A minimum five years' experience in providing auditorium stage curtain and experience in successful completion of at least one project in the similar nature at a total estimated cost not less than LKR 10 million.
  - The minimum amount of liquid assets shall be not less than LKR 15 million.

Bids shall be deposited in the tender box kept in the office of the Registrar or sent by registered post to the **Chairman**, **Department Procurement Committee of South Eastern University of Sri Lanka**, **Oluvil** to reach him before **02.30 p.m**. on **25.04.2019**. Bids will be opened immediately thereafter in the Board Room of the South Eastern University of Sri Lanka, Oluvil in the presence of the bidders' representatives who choose to attend.
